

STUDENT CONSENT FORM

I hereby consent to engage **High Performance Driving Academy** for Beginner Driver Education (BDE) program. I understand that "BDE" program services provided by **High Performance Driving Academy** includes In-Car Training and Online/Digital learning (In lieu of formal In-class Instructions). I understand that I have the following rights and Obligations with respect to BDE program provided by **High Performance Driving Academy**:

1. Online/Digital Learning:

- A. I will use my own computer/laptop for the purpose of Online/Digital learning.
- B. I will use my own premises for the purpose of Online/Digital Learning
- C. I will be personally meeting all the requirements to complete the Online/Digital program and **High Performance Driving Academy** is not responsible for the successful completion of this program.

2. In-car:

- A. I will be using **High Performance Driving Academy** certified vehicle for In-Car Training.
- B. I act responsible while undergoing In-Car training and behave responsible in handling the vehicle.
- C. I will listen to the direction of the In-car instructor and act as directed.
- D. I will be respectful and sober in my behaviour.

3. Road Test:

- A. I consent to **High Performance Driving Academy** to book or cancel my road after confirming with my schedule in writing /email/text message
- B. I have the right to withhold or withdraw consent at any time in writing/email/text message.
- 4. I understand that my instructor is a licensed Driving Instructor of Ontario duly authorized by MTO to give In-car driving instruction.
- 5. I understand that I will pay for my package (before the start of the package program) or for individual lessons (Before the Start of lesson).
- 6. I understand the following Covid-19 safety protocols:
 - A. I will be tested for fever before the start of the lesson.
 - B. I will be required to fill Covid-19 disclosure in every lesson.
 - C. In case I have any symptoms, I will stay and will update the instructor at the earliest possible. If I do not notify in advance, I will be charged for the lesson time.



- 7. Lesson Cancellation
 - A. I will give 24 hours notice before, in case I fail to give 24-hour notice, I will be charged for the lesson time.
- 8. Road Test Cancellation
 - A. I will follow MTO guidelines (48 hours)
- 9. In the event of winter or extreme weather conditions, an in-car lesson can be cancelled at the discretion of the in-car instructor with no penalty to the student. Weather-related cancellations are made at the discretion of the instructor only.
- 10. If an instructor takes a student to the road test center and the road test has been canceled after they arrive at the test center, full charges apply for the services rendered (in-car hours before the road test and use of car for road test charges).
- 11. The Beginner Driver Education Program consists of 20 HRS in class, 10 HRS of automatic in-car instructions and 10 HRS of interactive home assignment known as Drive Online.
- 12. Charges for using the instructors car for the ministry road test will apply in addition to the course fee.
- 13. Should you decide to dropout after starting your course, the entire fee will be refunded, except for those hours already attended plus a \$50 administration charge.
- 14. The complete course (Classroom, In car and Drive On-line) must be completed within one (1) year from the starting date to qualify for insurance certification. After one year the contract is automatically canceled and no refunds will be made.
- 15. Certification could be denied due to; a) Failure to successfully complete the required hours b) Failure of the in-class test, Drive On-line Test or car test conducted by the school.
